The darkly shaded page numbers represent flat A, and the lightly shaded numbers represent flat B. The two heavily outlined pages represent the two center pages, or natural spread, of the signature.

- Plan your deadlines by flats and signatures. Your pages are printed by flats, so all pages in a flat must be completed with approved proofs returned to production before they can be printed.
